### **DCSO Activities**

On 4/21/2010 Patrol Shift "A" Deputy J.L. Skinner made a traffic stop on a car with Arizona plates off of Thornton Road. It was discovered that the driver had confirmed warrants out of Cobb County, Georgia for obstruction. The driver also had a suspended license. The driver was arrested without incident.

On 4/21/2010 Patrol Shift "A" Deputy C. Ernst was dispatched to a 911 hang up call off of Craggy Perch in Douglasville. Upon arrival Ernst met with a female subject who stated she dialed the wrong number.

On 4/21/2010 Patrol Shift "A" Deputy J. Styles was sent to Lithia Way in Lithia Springs reference to a suicide attempt. Styles made contact with a 77 year old male subject who had consumed too much prescription medication. This male subject stated this was an accident and not a suicide attempt. The subject was transported to the hospital by Douglas County FIRE / EMS.

On 4/21/2010 Patrol Shift "A" Deputy J.L. Skinner was sent to an alarm at Douglas County Dodge on Thornton Road in Lithia Springs. Skinner found the night shift cleaning crew on site who stated the alarm was triggered by accident. No action taken.
