The Douglas County Board of Commissioners is soliciting RFQs from qualified firm(s) or organization(s) to provide On-Call Basis General Transportation Engineering Professional Services to perform Transportation Engineering Studies. The County intends to select a minimum of one, and up to two qualified engineering firms (Consultant) to conduct this work.

The Consultant shall provide design services that consist of development of GDOT Plan and Development Process required documents. This scope should cover all GDOT required permitting, plan submissions, coordination and all tasks required to let this project to construction. These documents include but are not limited to Concept Reports, Historical and Environmental Documents, Preliminary Design and Engineering Documents that include development of conceptual and design developmental documents and preliminary outline specifications, Final Design, and Engineering Documents that include the final concept and design development documents and approvals, final specifications, quantities and construction estimates, Utility Coordination, and Construction Engineering Services. These documents will be reviewed with the County for approval. The final documents will be suitable for inclusion in solicitation documents.
